8.Not - for - Profit Final Details -

Pursuant to the provisions of the By-Law No.1 and the Act, the Corporation has been continued under the Act by Articles of Continuance issued November 15, 2022 and next steps must ensure the Club is compliant with the Act.

A transition to reduce the number of Directors to nine, for the 2025 -2026 Board year will take place over a period of time to allow for a smooth transition.

Classification of members will be on the next meeting agenda.

9.SFG&CC Board Management Report - Gord Percy

A very detailed report regarding all areas of the club and course is provided prior to each meeting for the Directors to review and any questions or comments are addressed. The Directors are very appreciative for receiving this information; keeping the Board up to date. A hard copy of the entire report is attached to the approved minutes filed in the club office. Committee Reports:

a) Finance - Gord Percy / Bob Mulrooney

A large invoice for the deck project has been paid. At this time of year money is being paid out for wages, equipment repairs, government and loan obligations but little money coming in.

b) Membership - Gord Percy

Currently \$238K has been collected in memberships. Membership rates will be sent out the first week of February and interest seems strong.

c) Greens - Ron Dolinki / Gord Percy

To protect the Club from inventory shortages and continuing increases in cost, purchases are made ahead for parts, fertilizer and chemicals.

Many branches came down in the December wind storm requiring volunteer help in the spring to clean up. Tree removal continues.

Ken continues work on his accreditations.

A new utility vehicle needs to be obtained.

A decision on course layout needs to be made.

d) House - Roy Leach / Gord Percy / Paul Cadeau / Lynn Pominville

The deck project is progressing. The lift has been ordered and plans are completed. All the plumbing has been fixed and tiles installed. Flooring has been replaced downstairs and new LED lighting installed. The board and captains' rooms are the next project to tackle. New furniture for inside and outside will be available by spring. Parking lot lines will be painted.

e) Bar - Gord Percy

Sales to this point are a bit ahead of last year. The simulator opened earlier this year and has helped. A few small repairs in the bar area will be done over the winter months.

f) Pro Shop - Gord Percy

Purchasing for next season is almost complete.

The simulator is up and running. Some indoor fitting days will be done most likely in March. Waiting for an electrical panel to wire up a generator to provide power during outages.
